A legal problem is a problem with the law.



This book is about **family dispute resolution** or FDR.



Family dispute resolution is when family members try to end an argument over a legal problem.


What can the problem be about?

The legal problem can be about










• your divorce





- your money
- your home.



The problem can be about where your children will live in the future.



The problem might be about child abuse.

Child abuse is when someone hurts a child.



You might be afraid that your child is **not** safe with your ex partner.









You can go to court with the problem.

The law says you can only go to court if

• the problem is very urgent



• your children are **not** safe.



If the matter is **not** urgent you must have an **FDR** conference first.



An FDR conference is a meeting between

• family members

and



people who understand the law.



You can ask your lawyer to help you in the meeting.



Why can an FDR conference be a good idea?



An FDR conference can help you agree on what to do without going to court.

If you do **not** go to court you can





• save time

• save money



• have less stress.

Who will be at the meeting?

The people who can be at the FDR conference are

- you
- the other family member
 - for example, your ex partner
- lawyers
- a convenor
 - a convenor is a person who runs a meeting
- an interpreter if you need one
 - an interpreter is a person who can give messages from one language to another
- a support person if you need one.













Your support person could be

- a family member
- a friend
- your support worker.

Your support person may need to leave the room when people talk about private things.



You **cannot** bring children.



What happens at the meeting?

You will be in your own room.

The other family member will be in another room.




The convenor will

• move between your room and the other room




• listen to everyone



• help make a plan for you and your children.



The FDR conference can last for 3 hours.



You might be alone in your room for some time.



The FDR conference is **confidential**.

Confidential means nobody else will know what people talk about in the rooms.

If the convenor hears something that makes them think your children are **not** safe, they can

- call the police
- tell the court
- tell child protection
- end the meeting.









What if you cannot go?

You **must** go to the FDR conference

• if the problem is about your children

or



• you are **not** safe.




Speak to your lawyer if you **cannot** go.




Before the meeting

Tell your lawyer if you do **not** feel safe.

Find a person who can look after your children while you are at the meeting.



Think about where you can park for 3 hours if you come by car.




Think about how you and the other family member could make a plan for the future.

- What would be best for your children?
- What do you want for your home and money?
- Is there a better way to talk to each other?

If you agree




If both parents agree at the meeting you can make a plan for the future.




You can make a parenting plan.

A **parenting plan** is a plan between two family members that says what should happen next.



A parenting plan says

• where your children will live





• how often you can see your children.

The parenting plan is **not** a law.

Talk to a lawyer if someone breaks the plan.



You can also get a consent order.

A **consent order** is when a court makes rules you **must** follow.


A consent order is different to a parenting plan.



You can get in trouble with the court if you break the consent order.



Talk to your lawyer if you do **not** want to get a consent order.



If you do not agree

You might not be able to make a plan for the future at the FDR conference.

The problem might be that

• the other family member does **not** want to agree

or

• the other family member does **not** show up

or

• the problem is hard to agree on.



If you **cannot** agree you might get a **certificate**.


A certificate is a letter.





The letter says that you have tried to end the problem at an FDR conference.

What happens next?



If you get a certificate you can ask the court to decide how to fix the problem for you.

You have 1 year after the FDR conference to ask the court.



We can help you go to court.

We can also help you if

• you have a consent order



and

• the other family member breaks the rules.



What is the cost?

You may need to pay **5 hundred** dollars for the FDR conference.



If you do **not** have enough money, we can help you pay for the FDR conference.


