### What We Do

Legal Aid ACT offers FREE legal information, referral and advice to everyone in the ACT. We also provide ongoing legal assistance and representation to people who cannot afford a private lawyer.

We inform people of their legal rights and obligations to improve their access to the justice system. If you live outside the ACT we can put you in touch with a legal aid service in your area.

# **Free Legal Advice and Information**

We provide free initial advice and information to people in the ACT on most issues. We will not ask any questions about your financial circumstances before providing this advice.

#### By phone

Phone the Legal Aid Helpline. The Legal Aid Helpline will not give legal advice over the phone. They can make you an appointment to speak to a lawyer faceto-face and provide basic legal information.

# How can we help you?

#### Family Law duty lawyer

A free lawyer is on duty at the Family and Federal Magistrates Court to advise and assist people in family law matters. Monday to Friday, 10.00am to 3.00pm

#### **Mental Health**

Legal Aid can assist people who are detained under the *Mental Health Act 2015* (ACT). Our duty lawyers are at Canberra and Calvary Hospitals on a regular basis. Phone our Helpline for assistance.

#### Migration

Our migration clinic helps people with migration problems. There are appointments each Thursday. Phone the Helpline to make an appointment.

#### SUPPORT AND OTHER SERVICES

#### Liaison Officers

Our cultural liaison officers help people from a cultural and linguistically diverse background or who are Aboriginal or Torres Strait Islander. Cultural Liaison Officers help people understand the legal advice they have been given and can provide support throughout the legal dispute.

Our Family Violence Officer can work with you to ensure that you are safe and supported while you are dealing with a legal problem.

#### **Community Legal Education**

We undertake community legal education work by running seminars and workshops. We hold free information sessions on a range of matters. These include drink driving, licensing issues and family law.

### **Ongoing Legal Assistance**

If you need ongoing legal assistance or representation, you can apply for a grant of legal assistance.
